The exhibit dates are **October 10 to November 8, 2009.**

1. For this exhibit, we encourage you to explore the concepts of death and passages, using shrines/altars/icons to express your vision. You are invited to create a personal shrine of any type: journaling, honoring, remembering, healing, attracting, expressing, and exploring...even the absurd!
2. The exhibit is not juried and is open to all, regardless of age or calling. Groups or families may wish to collaborate in the creation of a shrine.
3. The medium(s) you use can be as open as your imagination, and both two and three dimensional works will be accepted. If assembly is required, the artist will be responsible for the assembly and **must schedule the installation with the curators.** This artwork may not weigh more than 30 lbs., nor be wider or taller than 60", without permission from curators. Wall-mounted work must have sturdy hanging support.
4. **The work must be no more than 2 years old** and may not have been exhibited publicly on the Mendonoma coast at any time.
5. **Entry Fee: \$10** for Gualala Arts Members, **\$15** for non-members. Please make checks out to Gualala Arts. Gualala Arts will maintain a tracking sheet of all pieces. Please fill out a Registration Form for EACH piece. Make copies as needed for yourself.
6. **Each artist is limited to 2 pieces total.** Gualala Arts takes a commission of 30% of the price of the artwork; the artist receives 70%. Work can also be "not for sale" (NFS). Artists are responsible for the legal and ethical integrity of their artwork. Artwork may be rejected by the curator if, in the curator's opinion, the work appears to be derived from another's art.
7. On **Tuesday, October 6, noon to 4 p.m.,** deliver altar/shrine/icon(s) to Gualala Arts Center. All entries must be hand-delivered; No mail-ins. Packing materials cannot be stored at Gualala Arts Center. Gualala Arts will provide an "Inventory Label" with information that will include the title, artist's name, optional subtext, selling price, and inventory tracking number for you to attach to your work upon delivery. Gualala Arts will create a receipt for each piece. This receipt is used for picking up unsold artwork on the pick-up day.
8. On **Monday, November 9, noon to 4 p.m.,** pick up art that has not sold. Gualala Arts charges \$5 per day to store art work not picked up. Items not retrieved after 90 days will be disposed of or sold, with Gualala Arts receiving the monies.
