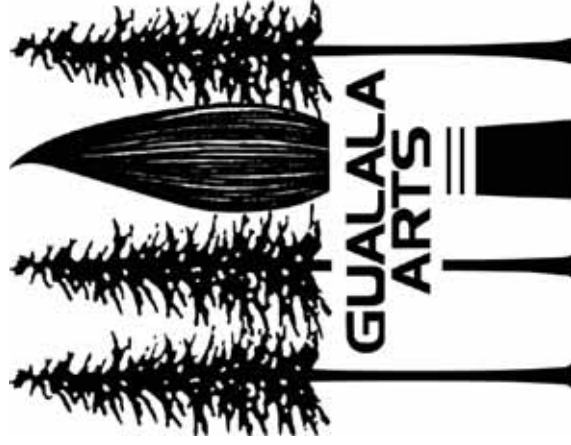

- Entries which have been accepted must be delivered to Gualala Arts Center on Tuesday, October 4.
- Opening Reception Friday, October 7, 5 to 7 pm. Bring finger food.
- Exhibit up through Sunday, October 23
- Take down Monday, October 24

Rules for Exhibitors:

- Each artist can enter 3 pieces.
- Non-refundable jury fee is \$5 per piece
A refundable entry fee for members (up to 3 pieces) is \$20. For non-members (up to 3 pieces) is \$35.
Example: member with 3 pieces is \$35,
member with one piece is \$25
- Each entry must be entered by a living artist who created the entry within the past two years. Entries must never have been exhibited at Gualala Arts before.

PRIZES

Prizes will be given according to the number of entries.

PROPOSALS

- Submit entry as a jpg image (300 dpi, 2700 pixel height) on DVD/CD. Label image file with first name, last name & title of art work.
- Submit artist statement/bio as digital file, 400 +- words.

PREPARING ENTRIES

- No supplemental labels, descriptions, books, promotional materials, etc., are allowed next to or around an entry. A binder with one 8.5" x 11" sheet of paper per entry will provide a description of the entry and the artist's biography. The binder will be available in the gallery for public viewing.

FEES

- Checks should be made payable to Gualala Arts.
- Entry fee is returned if none of your work is accepted.
- Proof of insurance may be required for work priced over \$5,000.

COMMISSIONS

- Gualala Arts will retain 30% commission on all sales of entries (or multiples) made during the course of the exhibit.
 - Checks for artwork sold will be mailed to the artist within two weeks of the end of the month in which it was sold. If the exhibit generates future commissions, it is the policy of Gualala Arts to request that 10% of those sales be sent to Gualala Arts.
- ### ENTRY PROCEDURE
- Each artist should sign an entry form and send to curator.
 - Print clearly, fill in all contact blanks, and double-check spelling.
 - Prepare a list with name of piece and price for curator. This list will be entered into the Gualala Arts database and used for selling and sending checks to the artists. It is also the contact information if a client wants to contact an artist.

ARTWORK DELIVERY

- Deliver artwork to Gualala Arts Center at 46501 Gualala Road, in Gualala.
- Gualala Arts will not accept shipped or mailed entries. No exceptions!
 - An artist receipt will be given to you for each entry on "take in" day to present for claiming unsold artwork.

POST SHOW PICK UP

- Unsold work must stay up for the entire exhibit; however, buyers may take purchased artwork after Opening Reception.
- Artists must claim unsold work on Monday, October 24 by 4 p.m.
- Gualala Arts is not responsible for works not picked up by 4 p.m. on Take Down Date and will charge \$5 per day per piece for storage.
- Packing items will not be returned to artists.

RESPONSIBILITY

- Gualala Arts, Inc. is not responsible for loss, theft, or damage of artworks entered in the show.
- Exhibitors are solely responsible for their work and should insure work if they desire. Gualala Arts may require proof of insurance if a work is priced over \$5,000.
- Gualala Arts will not ship purchases. If an entry requires mailing to a potential purchaser, Gualala Arts will contact the artist. If the artist wishes to package and mail the piece to the buyer, Gualala Arts will complete the purchase.
- Submission of an entry implies acceptance of all conditions stated in this document.
