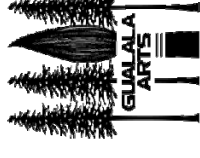

PREPARING ENTRIES

- No supplemental labels, descriptions, books, promotional materials, etc., are allowed next to or around an entry. A binder with one 8.5" x 11" sheet of paper per entry will provide a description of the entry and/or the artist's biography.

The binder will be available in the gallery for public viewing.

FEES

- Quilts available for purchase will have no entry fee.
- Entry fees for NFS (not for sale) items will be \$20.

COMMISSIONS

- Gualala Arts will retain 30% commission on all sales of entries made during the course of the exhibit.
- Checks for artwork sold will be mailed to the artist within two weeks of the end of the month in which it was sold.

ENTRY PROCEDURE

- Please print clearly, fill in all contact blanks, and double-check spelling. Be sure to sign the entry form.

ARTWORK DELIVERY

- Deliver artwork Wednesday, April 4, 10 a.m. to noon, to the Gualala Arts Center at 46501 Gualala Road, in Gualala, and help prepare exhibit.

- Gualala Arts will not accept shipped or mailed entries. No exceptions!

- An artist receipt will be given to for each entry on "take in" day to present for claiming unsold artwork.

POST SHOW PICK UP

- Unsold work must stay up for the entire exhibit; however, buyers may take purchased artwork after the opening reception.

- Artists must claim unsold work by Monday, April 30 from 10:00 a.m. to noon.

- Gualala Arts is not responsible for artwork not picked up by 4 p.m. on April 30 and will charge \$5 per day per piece for storage.

- Packing items will not be returned to artists.

RESPONSIBILITY

- Gualala Arts, Inc. is not responsible for loss, theft, or damage of artworks entered in the show.

- Exhibitors are solely responsible for their work and should insure work if they desire. Gualala Arts may require proof of insurance if a work is priced over \$5,000.

- Gualala Arts will not ship purchases. If an entry requires mailing to a potential purchaser, Gualala Arts will contact the artist. If the artist wishes to package and mail the piece to the buyer, Gualala Arts will complete the purchase.

- Submission of an entry implies acceptance of all conditions stated in this document.

GUALALA ARTS RESERVES THE RIGHT

- To its sole discretion to refuse to display any artwork.
